IN ADDITION, OUR STUDENTS ACHIEVED EIGHTY-SIX PERCENT (86%) IN GOOD BEHAVIOR AS MEASURED BY THE NUMBER OF AVAILABLE GOOD BEHAVIOR CREDITS EARNED AND MASTERY OF BEHAVIOR GOALS ON INDIVIDUAL EDUCATION AND

THESE SERVICES ARE DESIGNED TO PREVENT CHILDREN FROM BEING REMOVED FROM THE HOME OR SUSPENDED FROM SCHOOL DUE TO BEHAVIORS RESULTING FROM DIAGNOSED MENTAL DISORDERS. THE GOAL IS FOR EACH CHILD AND HIS FAMILY TO RECEIVE INDIVIDUAL, GROUP, AND FAMILY THERAPY AS INTERVENTIONS TO TREAT THE ILLNESS AND IMPROVE BEHAVIORS. AS A RESULT OF THE PROGRAM, NINETY-SEVEN PERCENT (97%) OF PARTICIPANTS WERE ABLE TO REMAIN IN THEIR ORIGINAL RESIDENCE AND AGGRESSIVE BEHAVIORS WERE REDUCED AMONG CHILDREN RECEIVING COUNSELING SUPPORT BY EIGHTY-FIVE PERCENT (85%).
