JOSEPH'S VILLA (INCLUDING THE ELEMENTARY SCHOOL PROGRAM), DOOLEY CENTER FOR ALTERNATIVE EDUCATION, BROOK ROAD ACADEMY, AND CAREER AND TRANSITION SERVICES (CATS). THE 2016-2017 SCHOOL YEAR WAS A VERY PRODUCTIVE YEAR WITH DOOLEY SCHOOL AT ST. JOSEPH'S VILLA ADMITTING 102 STUDENTS THROUGHOUT THE YEAR. THIS WAS AN INCREASE OF 21% OVER THE 84 STUDENTS WE SERVED IN THE 2015-2016 SCHOOL YEAR. DOOLEY SCHOOL ADDED AN ELEMENTARY CLASSROOM DUE TO INCREASED ENROLLMENT OF YOUNGER STUDENTS. ONE HUNDRED PERCENT OF DOOLEY STUDENTS MADE PROGRESS ON AT LEAST ONE OF THEIR IEP GOALS AND 8 STUDENTS PASSED SOL TESTS. NINETY-TWO PERCENT OF THE STUDENTS SUSTAINED OR IMPROVED THEIR GRADES THROUGHOUT THE SCHOOL YEAR. FOUR OF THE STUDENTS GRADUATED FROM THEIR
