DOOLEY SCHOOL AT ST. JOSEPH'S VILLA HAD A PRODUCTIVE 2017-18 SCHOOL YEAR SERVING 88 STUDENTS, WITH 31 COMING FROM NEW REFERRALS. ALL DOOLEY SCHOOL STUDENTS MADE PROGRESS ON AT LEAST ONE OF THEIR INDIVIDUALIZED EDUCATION PROGRAM (IEP) GOALS AND PASSED THEIR VIRGINIA ALTERNATE ASSESSMENT PROGRAM (VAAP) ASSESSMENTS. MANY STUDENTS PASSED THE STANDARDS OF LEARNING (SOL) ASSESSMENTS, INLCUDING SOME WHO HAD NEVER PASSED ANY SOLS PRIOR. 90% OF THE STUDENTS SUSTAINED OR IMPROVED THEIR GRADES THROUGHOUT THE SCHOOL YEAR.
