JOSEPH'S VILLA (INCLUDING THE ELEMENTARY SCHOOL PROGRAM), DOOLEY CENTER FOR ALTERNATIVE EDUCATION, BROOK ROAD ACADEMY, AND CAREER AND TRANSITION SERVICES. DOOLEY SCHOOL AT ST. JOSEPH'S VILLA ENDED THE SCHOOL YEAR HAVING SERVED 79 INDIVIDUAL STUDENTS FROM 79 FAMILIES OUT OF 102 REFERRALS. DOOLEY SERVED STUDENTS FROM 22 DIFFERENT LOCALITIES THROUGHOUT THE REGION. HENRICO, CHESTERFIELD, AND RICHMOND CITY CONTINUE TO PROVIDE THE BULK OF THE STUDENTS (59%). ALL DOOLEY SCHOOL STUDENTS MADE PROGRESS ON AT LEAST ONE IEP GOALS AND MOST MADE PROGRESS ON SEVERAL.
