DEAR FRIENDS

The Villa's work has never been realized alone. As we enter our 189th year of service to the community, we take time to recognize how your support propels us ever forward and lays groundwork for the success of our children and families. We're pleased to share some highlights of the past year with you in this Annual Impact Report.

In April 2023, we joined Henrico County and the Virginia Department of Behavioral Health & Developmental Services to break ground on Central Virginia's first Youth Crisis Receiving Center (CRC). We are incredibly excited for this major milestone in making essential mental health crisis services immediately accessible to children and their families. The CRC will be housed in a newly renovated building on the Villa campus, and will be a valuable resource providing 24-hour emergency services. It will expand the capacity of Virginia's mental and behavioral health system, and offer support in a setting custom designed and staffed for youth in mental health crisis. We look forward to opening this program in early 2024.

The national affordable housing crisis also continues to be a pressing issue. With the lifting of the eviction moratorium and challenging rental markets, last year our Flagler Housing & Homeless Services team responded to over 4,000 calls for assistance, and helped move hundreds to safe and stable housing while providing others with vital prevention and diversion resources. Additionally, the number of clients served by our Richmond and Petersburg offices has increased an average of 26.7% each year for the last 4 years. Each day we learn from the experiences of our clients, and collaborate with our partners to create viable, effective solutions for ending chronic homelessness.

In our education services, we had the joy of helping several students successfully transition back to their zoned public schools, and celebrated the culmination of our graduates' hard work as they received their diplomas. This year, our Center for Autism is beginning to host trainings for teachers, local law enforcement, and community partners, to help ensure that every child with an autism diagnosis receives education and community support that supports their growth and success.

Looking toward our future, our dedication to providing quality education, therapy, and trauma-informed care to the most vulnerable children and families in our community remains at the core of who we are. This mission inspires us to evolve our programming, to remain nimble and responsive to our community's most critical needs, and to deepen relationships with all who share in our work.

Please accept our sincere gratitude for being a member of "Team Villa." None of our work would be possible without our incredible family of staff, donors, volunteers, and partners. It's your belief in the Villa's mission that creates the blueprint for our continued success.



Year Ending June 30, 2023




